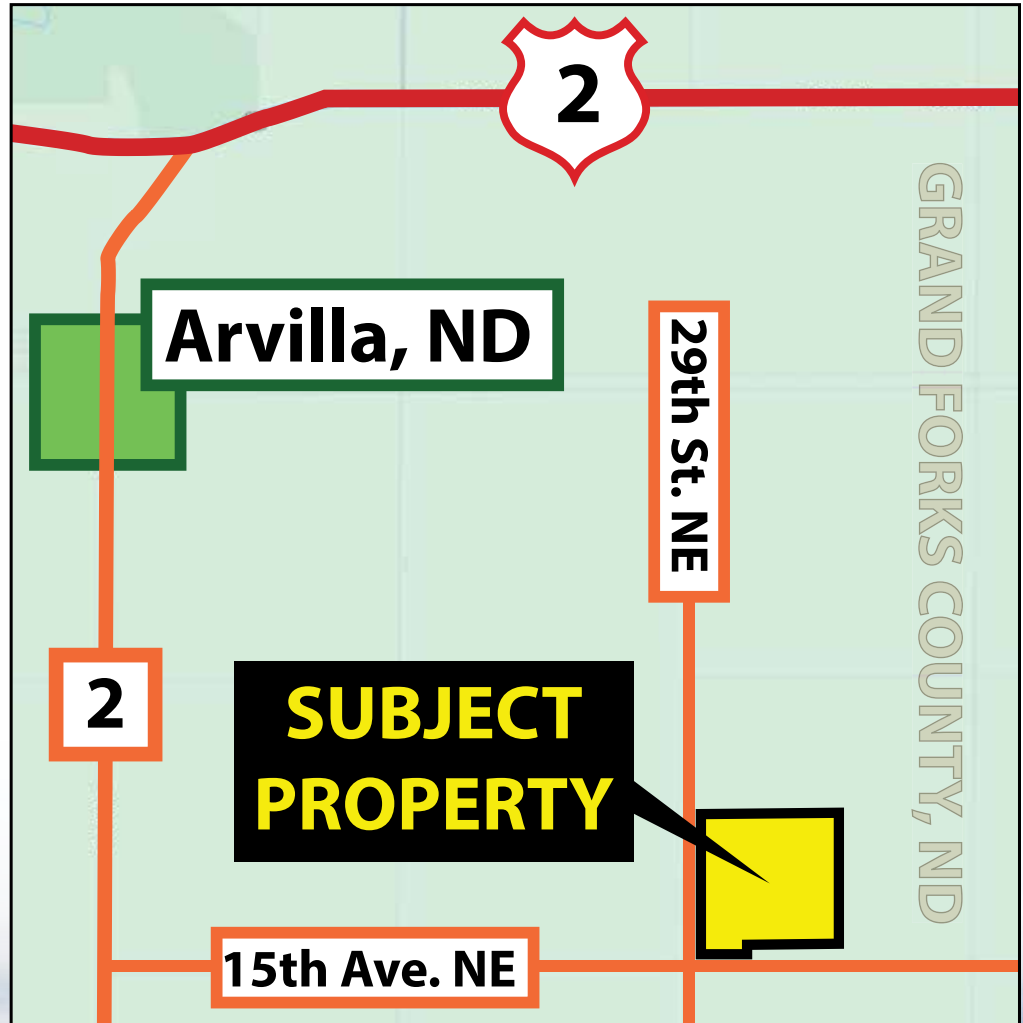

INTRODUCTION

Auction Note: This farmland auction in Chester Township features 135.73 +/- crop acres with a Soil Productivity Index (SPI) of 63.6 that consists of mostly Class II & III loam soils, mostly Arveson Loam, Borup Silt Loam, Bearden Silty Clay Loam and Colvin Silty Clay Loam. The remaining acres includes trees and wetlands providing great hunting opportunities. There is a large legal drain on the south and east sides of the property.

From Arvilla, ND, proceed 2 miles south on County Rd. #2, then 2 miles east on 15th Ave. NE to the southwest corner of the property.



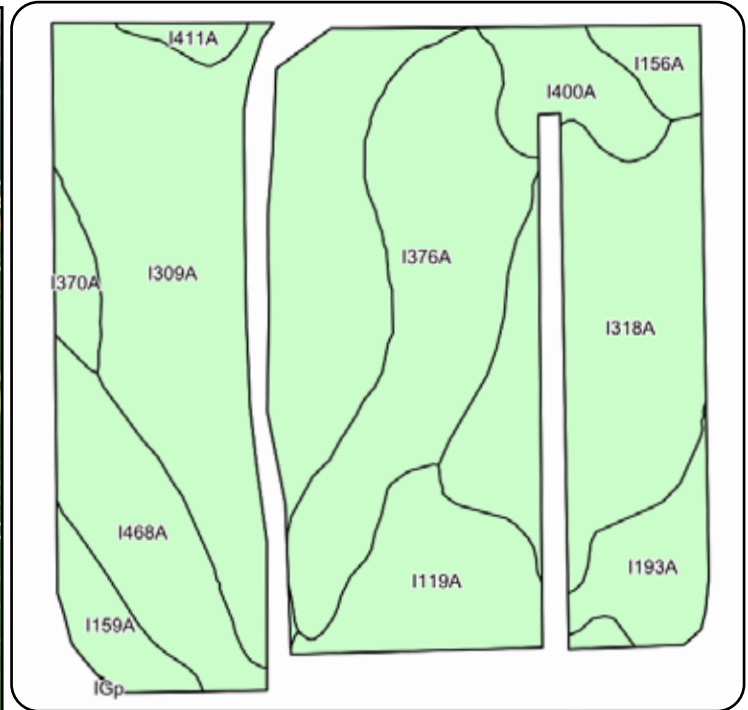

TERMS & CONDITIONS

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

III. Purchase Agreement, Marketability, Signing Area

At the time the auction is complete, the successful high bidder must sign a standard Real Estate Purchase Agreement to purchase this property for which it was the high bidder.
