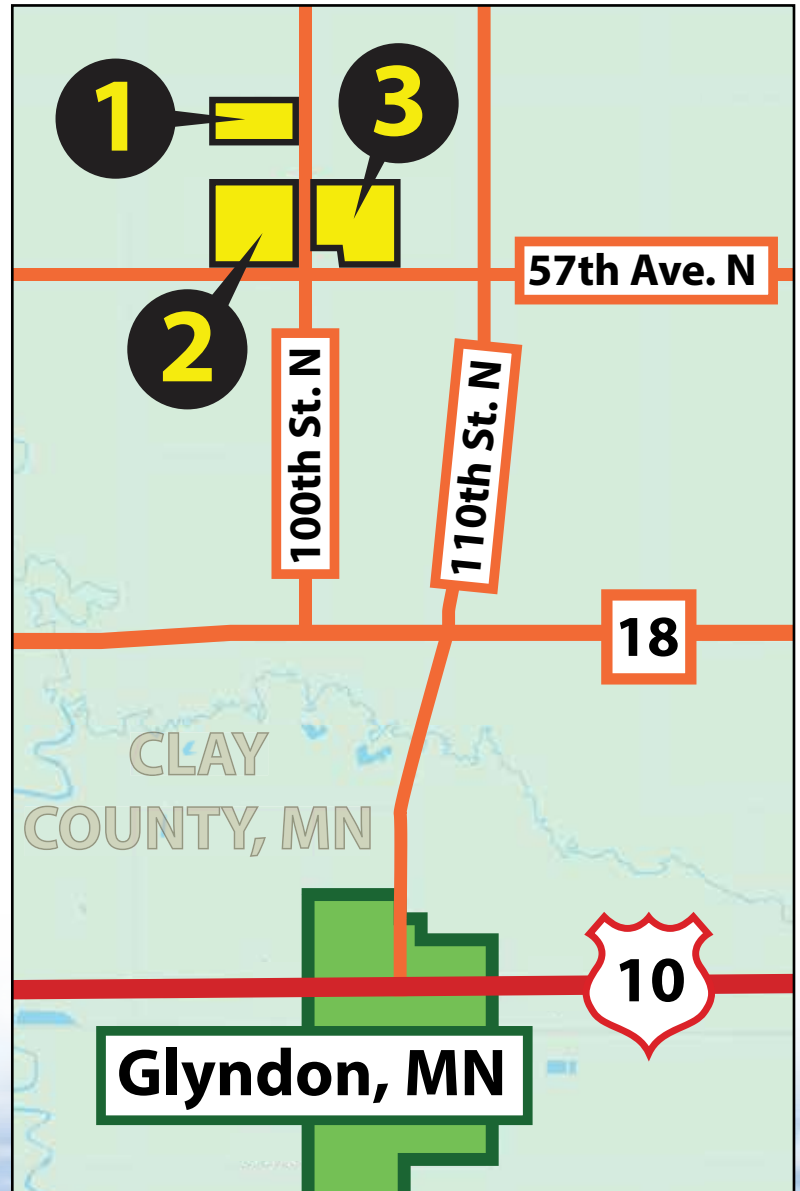


# INTRODUCTION

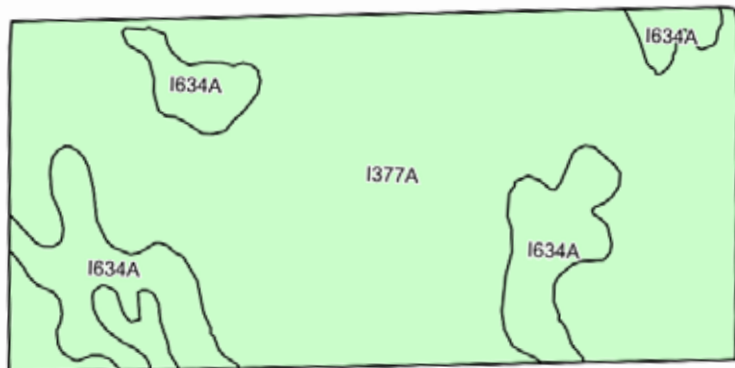

# TERMS & CONDITIONS

## I. Terms and Conditions of Auction
