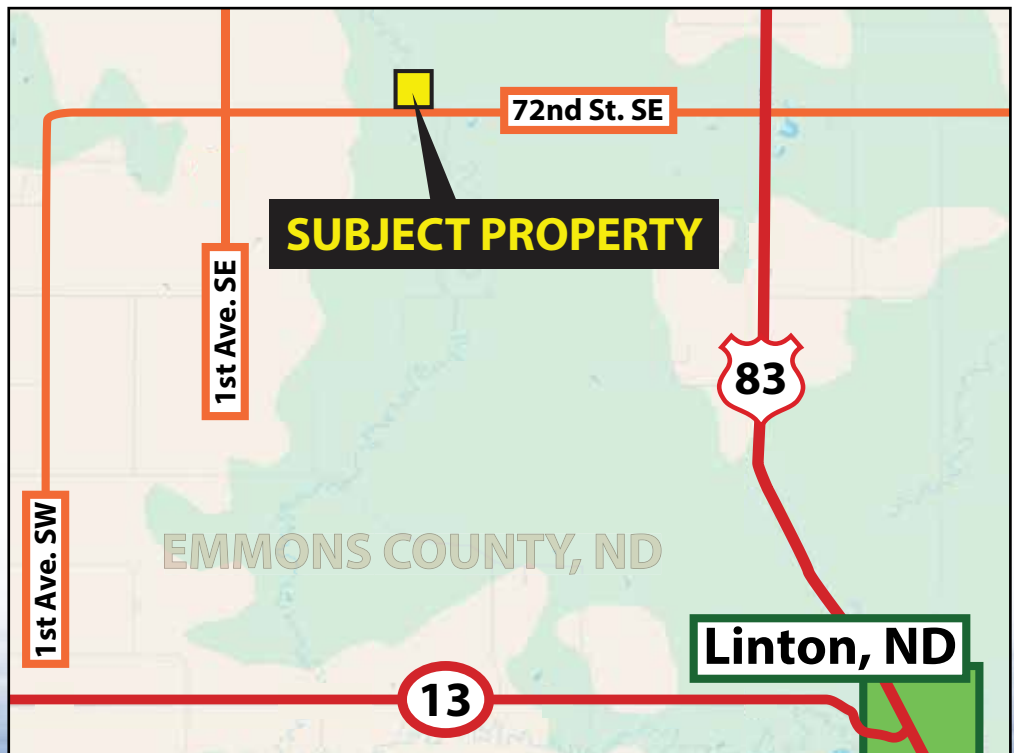
# INTRODUCTION

Located in Emmons County, this 157.69 +/- acre property offers a great mix of productive farmland and excellent wildlife habitat. With over 45 +/- acres of productive cropland, there is plenty of room for food plots, farming, or added income potential. Sand Creek winds through the southern portion of the property, creating rolling valleys, natural cover, and ideal habitat for Whitetail deer, pheasants, grouse, and other wildlife. From early morning sunrises over the prairie to colorful North Dakota sunsets in the evening, this would make an excellent location for a future home, hunting cabin, or weekend getaway in the heart of South Central North Dakota. The property also features easy access, located just 15 minutes from Linton and about an hour from Bismarck and is free of US Fish & Wildlife Service (USFWS) easements.

Sellers will retain subsurface mineral rights. This property will be selling subject to First Right of Refusal.

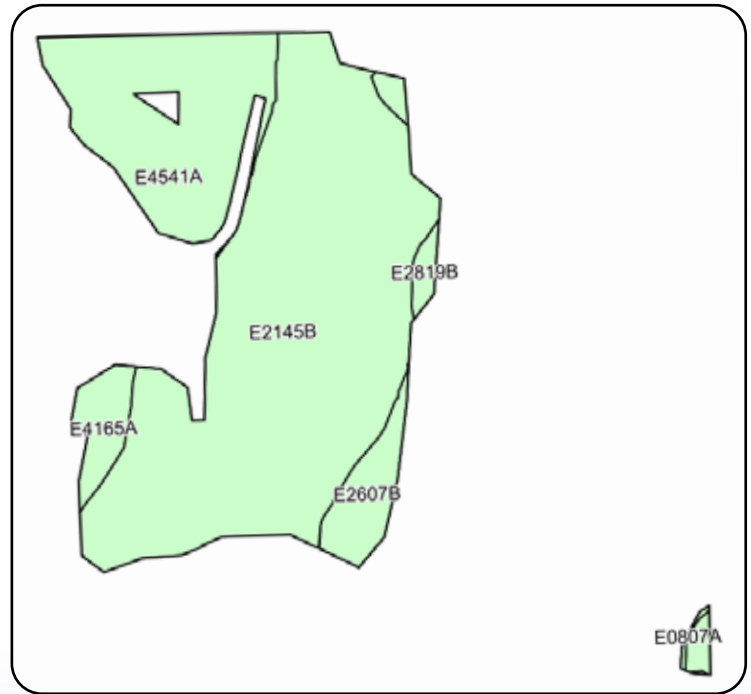

# TERMS & CONDITIONS

## I. Terms and Conditions of Auction
