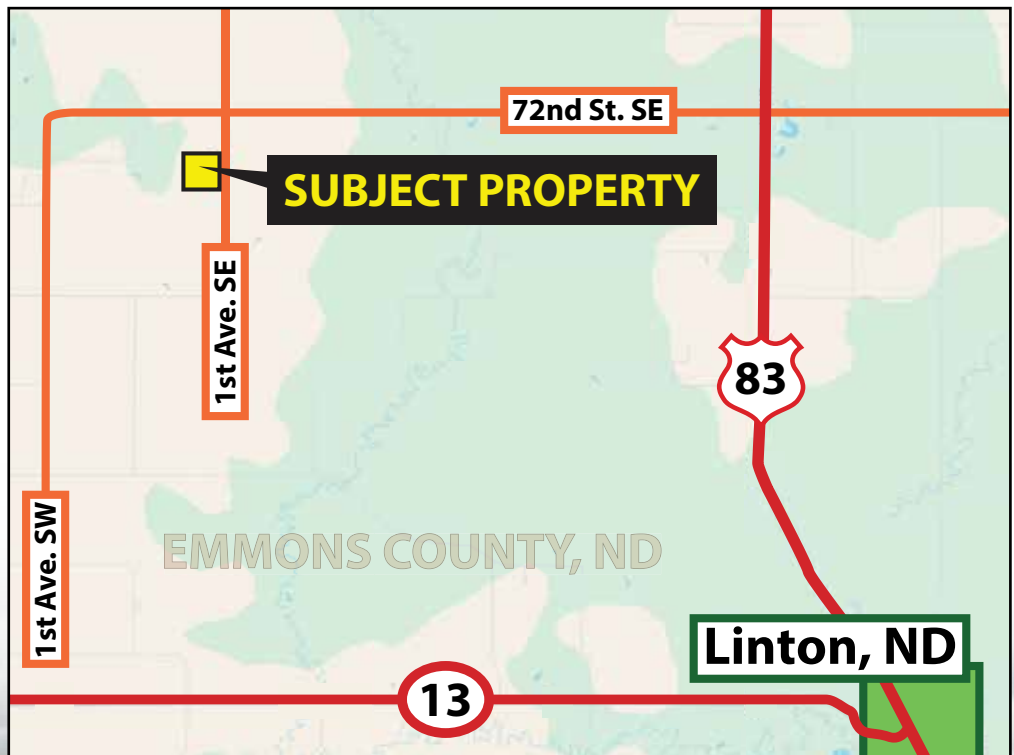
# INTRODUCTION

Featuring over 102 +/- acres of productive cropland, the property boasts strong Soil Productivity Indexes (SPI) in the 70s, with predominant Armor-Werner Loams providing a solid foundation for consistent crop yields. In addition to its farming appeal, the property includes a scenic draw and lush native grasses, these natural features enhance the land's wildlife habitat, creating an attractive setting for farmers and hunting enthusiasts. The land is free of US Fish & Wildlife Service (USFWS) easements and is available for the 2027 crop year. Sellers will be retaining all subsurface mineral rights. This property will be selling subject to First Right of Refusal.

This parcel is subject to a ND PLOTS Agreement through March 31, 2027, however the contract will terminate on December 31, 2026 upon the change of ownership. The new owner may choose to complete the contract or enter into a new agreement.

From Linton, ND, take ND Hwy. #83 north for 7 miles. Turn west on 72nd St. SE for 6 miles, here you will be at the southeast corner of the property. Turn south on 1st Ave. SE for 0.5 miles, here you will be at the northeast corner of the parcel.



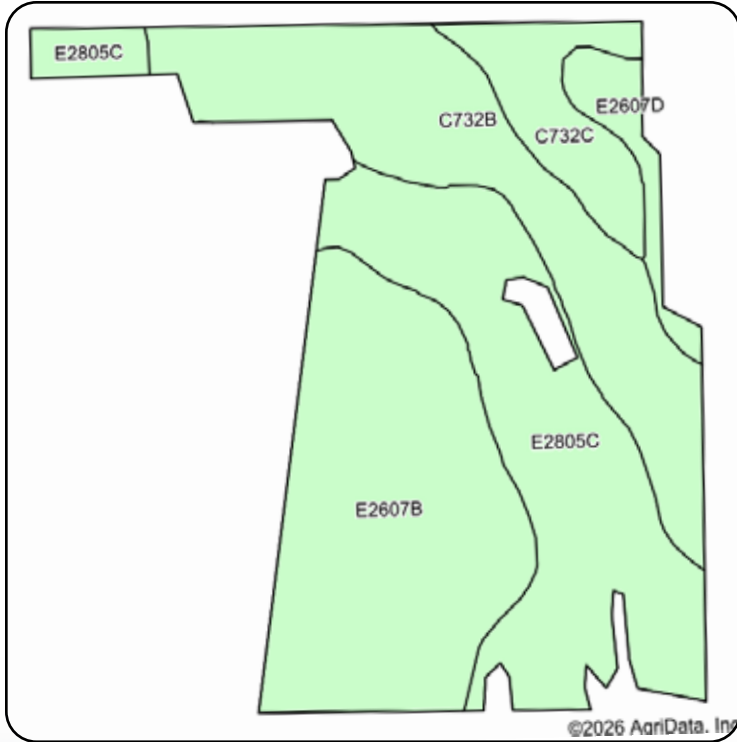

# TERMS & CONDITIONS

## I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

**A.** If you intend to bid on this property, you will be required to provide a cashier's check or personal check in the amount of 10 percent of the purchase price as earnest money on the date of the auction. ## II. Bidding Procedures

All bidding is open to the public. You need only to raise your hand and shout out your bid, or instruct any of the ring men to do so on your behalf. Anyone who wishes to bid must first register to obtain a bidder's card at the registration desk.

Retain your bidder number for the duration of the auction. You are responsible for your assigned number. The property is sold when the Auctioneer announces, "sold," identifies the winning bid number and the amount of the bid and the information is recorded by the Auctioneer or his designee. In case of a tie bid, bidding will be reopened between the two tied bidders. The high bid cannot be withdrawn once the Auctioneer determines it to be the winning sale bid.

## III. Purchase Agreement, Marketability, Signing Area

At the time the auction is complete, the successful high bidder must sign a standard Real Estate Purchase Agreement to purchase this property for which it was the high bidder. An appointment date to close the transaction will be furnished to the Purchaser after the Purchase Agreement is signed.
