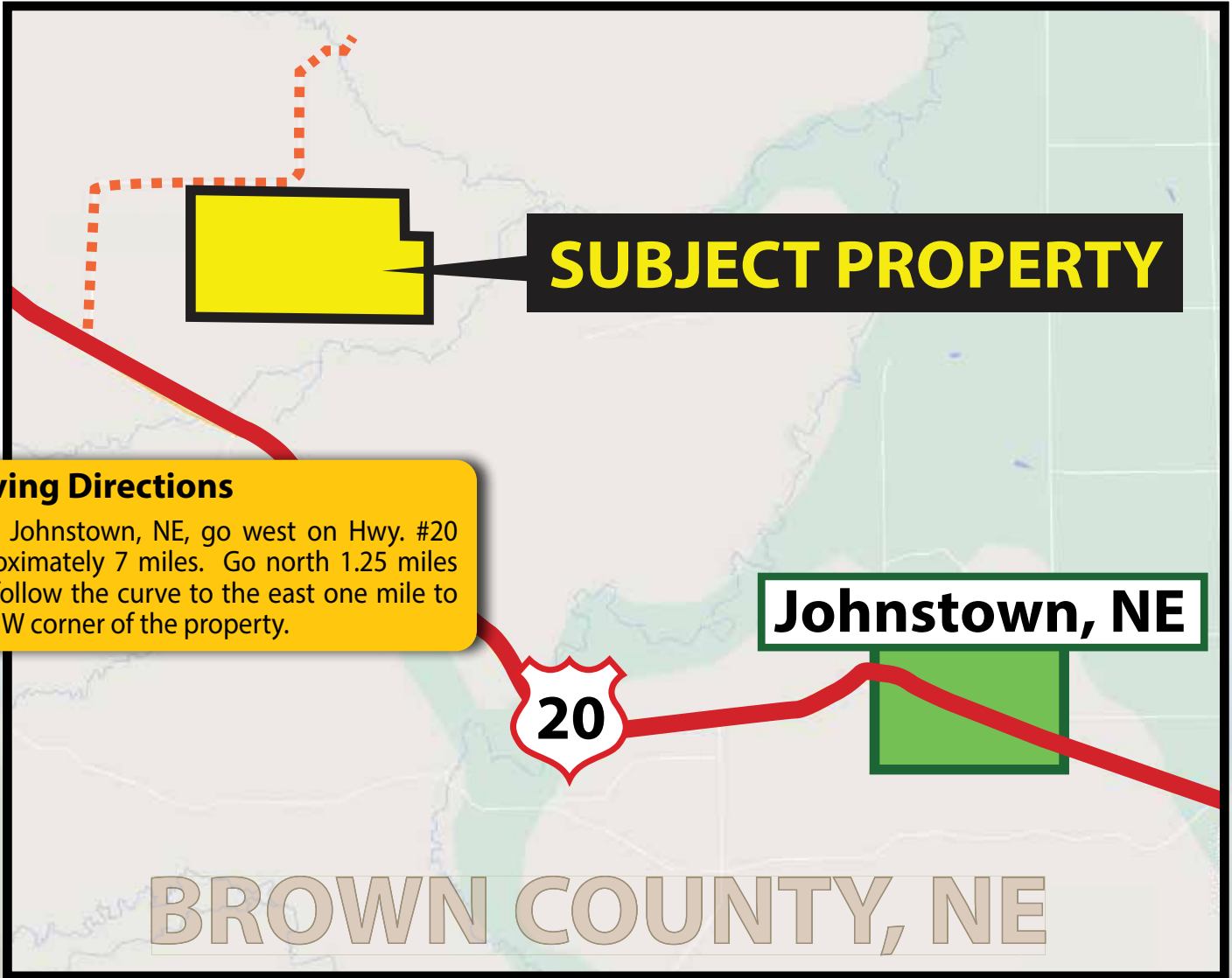

# Terms & Conditions

## I. Terms and Conditions of Auction

A.
